Spring is coming! It's time to freshen up the landscape. As most of you know, this winter RDD contracted with a company to clear off the overgrown vegetation along the banks of Mallard Lake. They went out in boats and along the shoreline and removed the overgrowth. Some of the plants that were removed were noxious or invasive plants that potentially can harm the water quality of the lake. Now that the plants are removed, the District has arranged for new plantings to be installed along the lake shore that will help purify the water. Soon you will see Pickerel grass, arrowhead and small cypress trees planted in the water. They will grow and give more cover to the fish and other wildlife and improve the overall health of the lake. Hopefully, if this program is successful, we will be able to duplicate the plantings on all the lakes in the District

Codes & Covenants Section 4.5 -- Parking, p2

Travel trailers, recreational vehicles, boats and trailers must be parked behind the front wall line of the home and upon a concrete slab (Observation is made for parking of above mentioned, behind the front wall line of the home -- thank you for a partial clearance. However, please be advised; **parking must be upon a concrete slab.** You are also obligated to park your travel trailer, recreational vehicles, boats and trailers on a concrete slab.



Last year Wedgefield became one of only **seven** communities nationwide accepted into a pilot program called **FIREWISE Communities USA**. As part of this program, Wedgefield is helping to establish the criteria that other communities across the country will have to meet in order to become certified as a **FIREWISE Community**.During the past several months as a group we have investigated ways to reduce the risks of wildfires to property and homes in Wedgefield. We invite you to attend our next monthly meeting at the Ranger Drainage District building on Tuesday, April 16th at 1:30 p.m. The major topic of discussion will be our March trip to San Diego, CA to meet with other FIREWISE communities. On March 15th the Wedgefield community lost a friend.


Mr. Michael Daniel was killed in a tragic accident in Wedgefield, and he will be missed by all that knew him and many that never had the chance. Mike was the caretaker of the Hal Scott Regional Park that adjoins the Wedgefield property west of Dallas Blvd. I am sure that many of you that never had the privilege to meet Mike have walked the trails of that beautiful parkland in all of its peace and tranquillity. He was the consummate watchman over the park, and it was not uncommon for him to be chasing poachers around and out of the preserve at three in the morning. This was his life and this is what he enjoyed doing, not for any accolades from the community or the people that use the preserve, but for the sake of doing it (and to remind those who dared, just who really owned the park, the tax-payers)


I have many fond memories of Mike and the simple life that he led. He was selfless in all things, to the point that if you needed anything at anytime, he would be the first to respond. "Mike, can you help out with the Children's Fishing Outing." "Mike can you pull a car full of U.C.F. students out of a ditch ." (At two in the morning) When the fires decimated our state, he was standing on top of his post calling in the crews to the fires just starting around us. Yes, this was his job, but he took it way beyond that. It was personal to Mike because he loved Wedgefield. I can recount countless events that shaped my memories of Mike, but the one that is the most poignant to me is standing in the emergency room with his wife and not being able to respond in kind. Of all the effort and life he gave to this community, I could do nothing to help him, his wife, or their two young girls. Godspeed Mike, we will miss you.

As a community, I ask that we respond the same way Mike would have responded to our needs. We are in the infant stages of starting a community fund for his family, and I am asking for your help. Mike was ten feet tall and bulletproof in life and like most of us at his age, was not prepared to die. I ask these things not because he is more deserving or better than the rest, but because he leaves behind a family in need. 
